



## INFORMATION NOTE ON DATA PROCESSING AND PROCESS DESCRIPTION FOR USING COOKIES

**Crystal WorldWide Szolgáltató Zártkörűen Működő Részvénytársaság (hereinafter “Company” or “Controller”)** hereby informs you by way of this information note and process description and all facts related to processing your personal data in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter: GDPR). By participating in the process, you will become the data subject of the processing according to this process description.

### PROCESS DESCRIPTION OF THE PROCESSING:

Controller shall use the website <https://crwwgroup.net/> to share and publish its content.

Accessing and leaving the website by the Visitor shall be assisted by small data packages, so-called cookies, functioning according to the cookie-settings, to be placed on and read from Visitor’s IT tools by the website. The cookies serve the purpose of the proper operation of the website, the more efficient service as well as anonymized data collection for statistical purposes.

The Visitors may delete the cookies from their IT tools, or – according to the settings of the tools – they may be automatically deleted upon closing the browser; the visitor may also manually set the browser to block the application of cookies. The Visitor can also use the website if the application of cookies has been manually blocked in the browser settings.

By visiting the Website and clicking on the “Elfogadom” button the Visitor approves the Controller using in the context of the operation of the website cookies managed by external service providers or by itself for the purpose of the potential recording of data, information specified in this Information Note, subject to the settings.

Such data include the data of Visitor’s computer generated in the course of using the Website and recorded by the cookies used on the Website as the automatic result of technical processes. The automatically recorded data will be automatically logged by the system, without User’s individual statement or action, upon accessing and leaving the Website.

The data saved according to the settings shall not be connected to other personal data of the user; the data will be accessed by the external service provider (e.g. Google) processing the cookies and by Controller. Visitor shall not be identifiable on the basis of these data.

**PURPOSE OF DATA PROCESSING:**

Identification of the visitors of the Website, automatic data recording of the accessing and using customs with the help of cookies aimed at allowing and facilitating the Workflow, improving the user experience, customizing and statistical data collection.

**TITLE OF DATA PROCESSING:**

The data subject’s consent under Article 6 (1) a) of the GDPR.

**SCOPE OF THE DATA PROCESSED:**

Visitor’s IP-address.

**SPECIFICATION OF THE DATA PROCESSORS INVOLVED IN THE DATA PROCESSING AND THE DATA PROCESSING OPERATION:**

Controller shall not involve a data processor in the data processing.

**IN THE COURSE OF THE PROCESSING, DATA WILL BE TRANSFERRED TO THE FOLLOWING THIRD PERSONS UNDER THE SPECIFIED TITLE:**

Controller shall not transfer data to third parties, however, the data subjects are reminded that the law may order the disclosure of personal data to the court or authority. If, by way of its procedure regulated by the law, the court or the authority binds the Controller to disclose personal data, the Controller shall comply with its statutory obligation of disclosing the requested data to the proceeding court or authority.

**PERIOD OF STORING PERSONAL DATA:**

Until the data subject’s deletion request, or in the absence of such request until the realization of the purpose of processing, but for not more than 2 years.

**EXISTENCE OF AUTOMATED DECISION-MAKING:**

Automated decision-making shall take place during the processing.

**Data subject of the processing:** website visitor

**Method of data storage:** electronic

**Rights of the data subject:** revocation of consent, rights to access, correction, deletion, restricting and data transferability (in the case of automated processing)

**RULES ON EXERCISING THE DATA SUBJECT’S RIGHTS:**



Controller hereby informs you that you may exercise the following ways to enforce rights upon the verification of your identity:

- request information on the processing of your personal data,
- request the rectification of your personal data,
- revoke your consent to data processing,
- request the deleting of your personal data, if any of the conditions under Article 17 (1) of the GDPR are met,
- request the restriction of processing your personal data,
- exercise your right to data transferability, if its conditions are met,
- seek legal remedy.

Controller will make efforts to provide you in each case with information that is as concise, transparent, easy to understand, accessible, clear and plain as possible, by also complying with the rules of the GDPR.

Your request should primarily be submitted in writing, addressed to Controller's representative at the contact details specified in this information note. Our staff member shall record the request and you shall receive a reply to your request within one month upon receiving the request. We may extend this deadline by not more than two months, provided that it is justified by the complexity of the request or the number of requests actually handled, however, we shall inform you on the extension within one month in electronic form.

If we fail to take measures upon your request, or you do not accept the measures taken, you may seek legal remedy. you may turn with complaints related to our data processing procedure to the Hungarian National Authority for Data Protection and Freedom of Information or to the regional court having jurisdiction according to your place of residence or place of stay.

Please be informed, however, that according to the practice of the Hungarian National Authority for Data Protection and Freedom of Information, your complaint will only be admitted, if you first turn to the controller, i.e. to us, but we fail to act according to your request, or you do not accept the measures taken. We recommend you to first contact the representative of the Controller!
